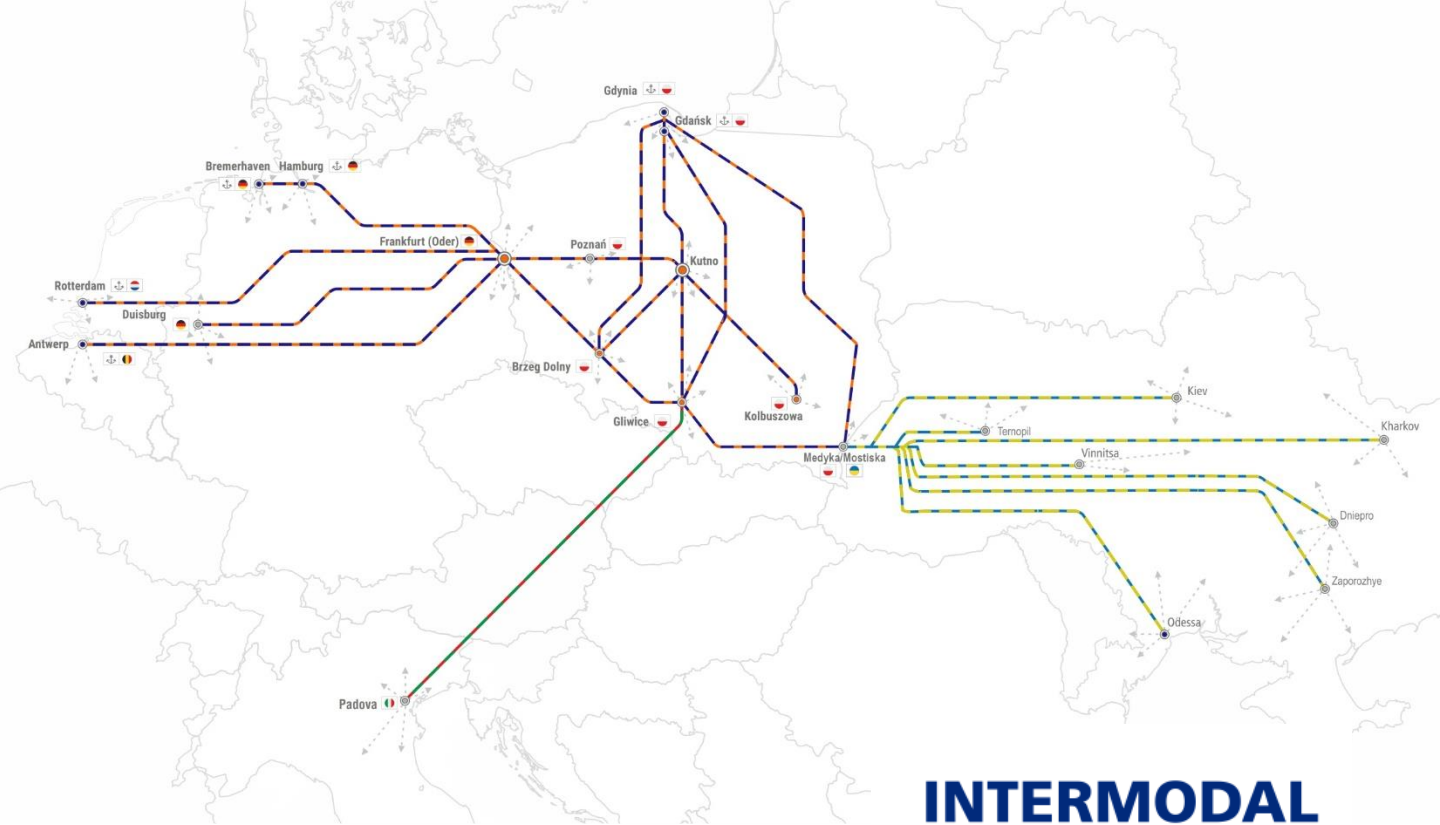

"Manipulation fee"

- mandatory fee, for each container beeing transshipped via DCT Gdańsk and BCT Gdynia
- the fee does not apply and is not charged for containers transshipped via GCT Gdynia

- manipulation fee will be shown as a separate position on the invoice
- the amount of the fee is calculated based on the current tariff rates published by DCT and BCT terminals and is averaged overall days of the week, including weekends and state holidays.

Weight remarks

When calculating the rate for 20' containers, with total brutto weight exceeding 22 tones, use 30' rates.

When calculating the rate for 20' / 30' containers, with total brutto weight exceeding 30 tones, use 40' rates.

CUSTOMS SERVICES

For clients using PCCI intermodal services we offer Customs support and services under following procedures:

- export
- transit (T1/T2)
- import
- customs temporary storage (DSK/ATB)

¹ Refers to the changes ordered after cut off; cut off – agreed with Customer Service deadline for delivering the container to the starting terminal & supplying all the documents needed to provide the service according to the booking order

² The fee do not added when using data available in PCC Intermodal system and presented in the clients on-line zone

³ The fee for failure by the client to close on time a customs procedure opened by the PCCI (including T1 and ATB procedures). It is charged when the customs system of the country of opening or closing the procedure shows a message that the customs procedure was not closed on time. The fee is charged for every day following the planned date of closure of the procedure until the date of the actual closure of the procedure in the customs system where it appeared as open or until all discrepancies with the customs authorities are resolved.

It covers the documentary and organisational steps taken to clarify the matter before the customs authorities and the involvement of the PCCI customs liability

⁴ The fee for making a document scan available. Does not apply to scans of transport documents not older than 6 months made available in the PCCI system in the clients on-line zone.

⁵ This is a fee for documentation and registration activities required by law for the transport of certain types of cargo, e.g. goods covered by the statutory transport and trade monitoring system (i.e. SENT goods, subject to the provisions of the Act of 9 March 2017 on the monitoring system for the road and rail transport of goods and trade of heating fuels, waste, feed, animal by-products and derived products, precursors drugs, known as registered cargo.). The fee is charged for each order for each intermodal unit with a registered load, except that it is charged once for a given unit, even when the load is subject to several different administrative obligations at the same time.

⁶ Fee is charged if, at least 48 hours before the scheduled start date of the order, the customer does not provide the CN or HS code of the load or does not inform in the order that the subject of the service is a unit with a specific registered load subject to administrative obligations. The fee is charged for administrative services related to the need to take additional explanatory actions. The charged fee does not limit PCCI's right to claim compensation from the Client for damages resulting from the lack of complete information in the order placed by Client.

⁷ A fee for the collection, at the client's request or in relation to the claim they refer to PCCI, of available materials confirming the condition of the unit during the execution of the order (photos, videos, scans of documents). the fee is not charged if the materials show that PCCI or an entity acting on behalf of PCCI is responsible for the damage;

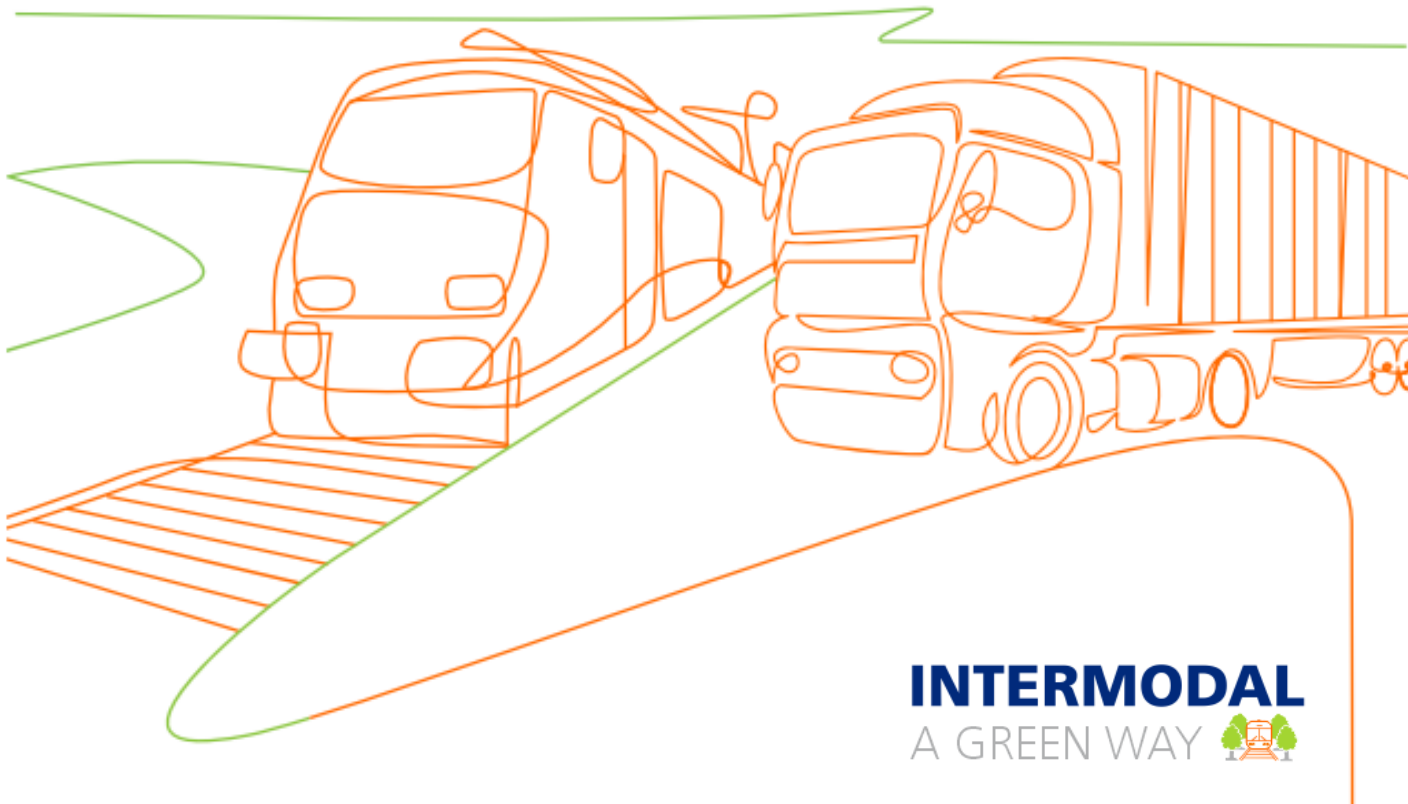

REMARKS:

- reloading of a container train-yard or truck- yard or v.v.
- transshipment rate is applicable for direct train-train reloading or when time period between commencement of the terminal slot for train A and end of the terminal slot of train B do not exceed 24 hours; the rate refers to additional handlings connected with transshipment within the terminal for service requirements, container repairs, washing, use of emergency tub, handling between the trains, weighing, container status/condition check etc.)
- calendar days, including the date of drop off / pick up the container;
- the rate per day of usage; it does not include the cost of handling and neutralization of pollutants;
- only fitting, without flexi tank and additional materials;
- service is not available in LD Kolbuszowa; the rate does not include handlings; refers to a single wash; not possible in autumn/winter season; does not apply to hazardous goods and/or containers after waste unloading;
- applies only to PCCI terminals with VGM scales; rate assumes performance of ordered, previously planned weighing operation, being a part of transport order; does not apply to situations where weighing requires moving a container from yard or from external truck to scales
- Any inspection of the condition of the container, its fixtures, equipment or seals at the request of the customer, including the data reading/reporting.

1. Any other services not mentioned in the tariff, if are possible to be served by the Terminal can be secured/proceeded only with the separate contract signed ahead.
2. Storage services exclude warehousing and storage of the hazardous goods. UTI with IMO can be only accepted on the terminal when changing the transport mode is needed for transshipment operations during the transportation process. The total storage time for transported IMO can not exceed 24h as from the time UTI was accepted to the terminal, excluding approved emergency situations.

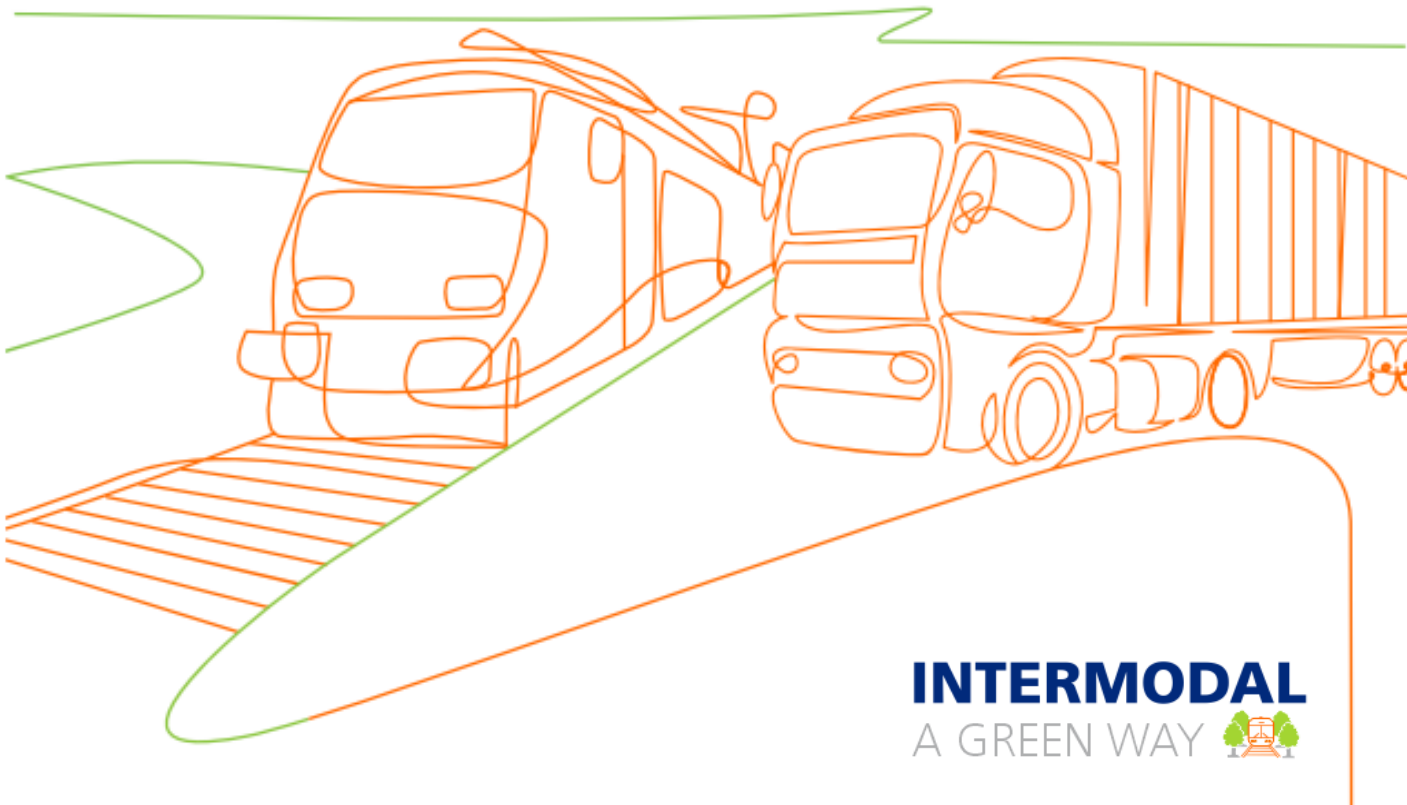

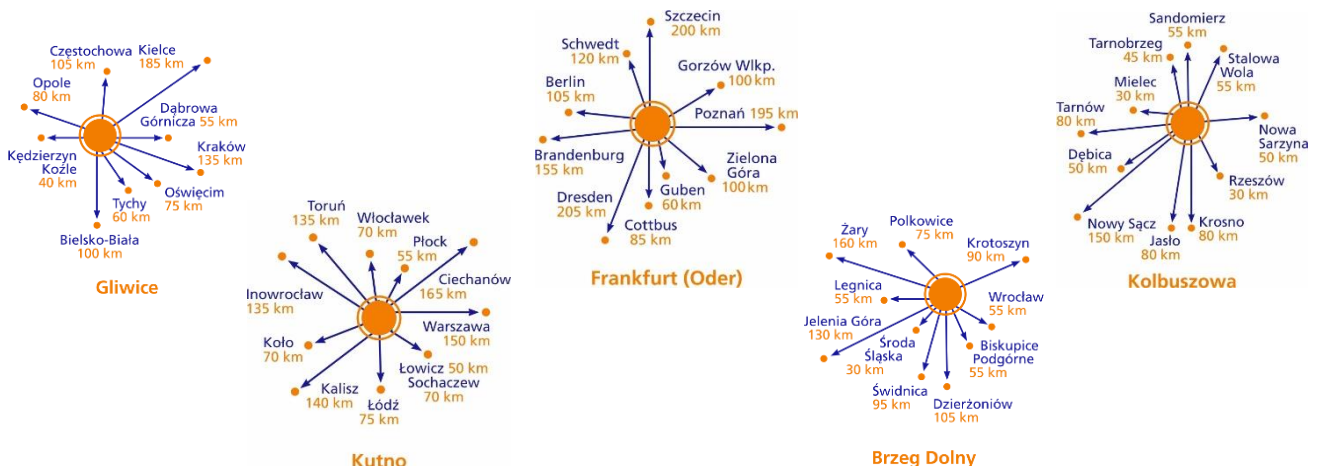

- The rates do not include handlings.

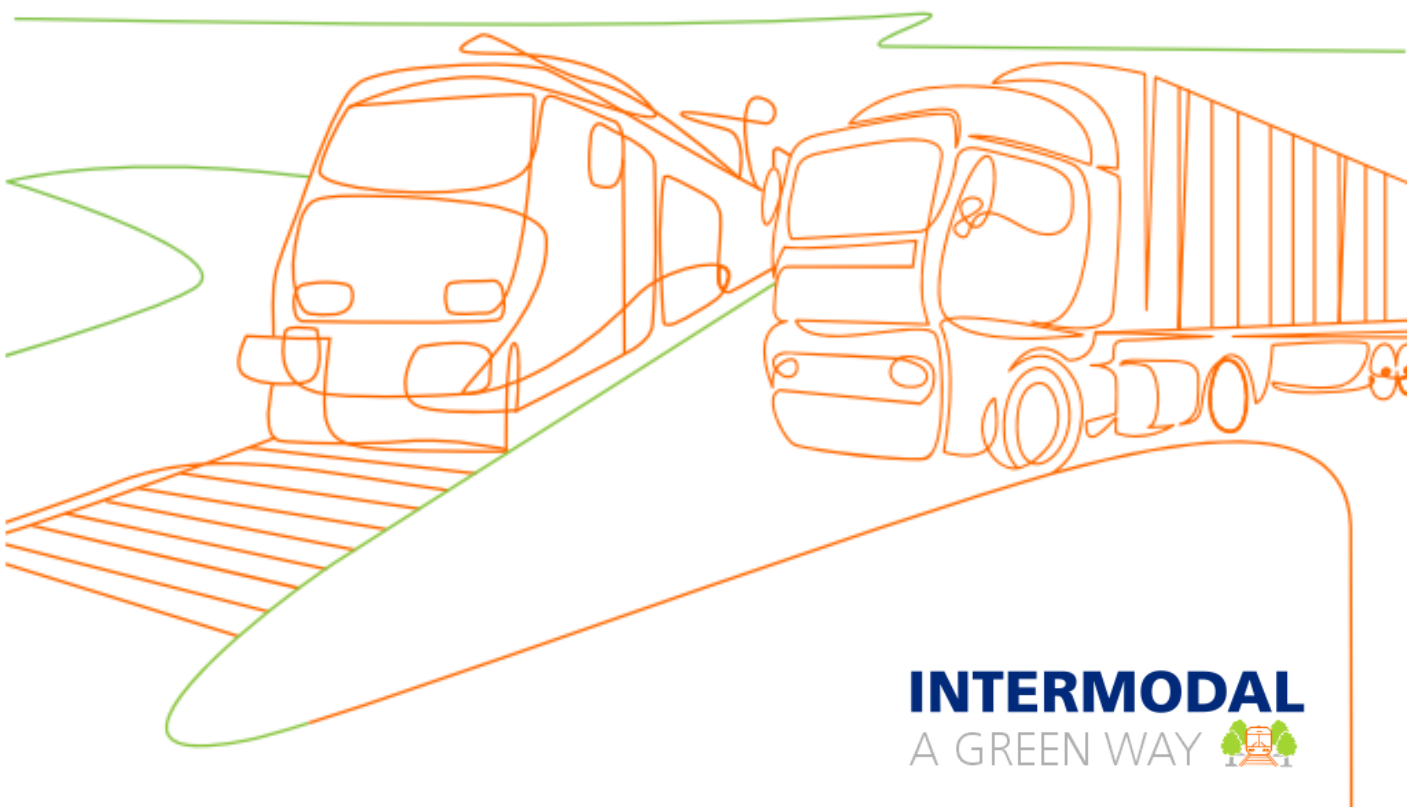
